1. Opening Address

- 1.1 Mr. Matthew Lee reported that of the 32 Ordinary Members with voting rights, 18 were present. As the minimum quorum of one-third of the total number of Ordinary Members with voting rights had been reached, the meeting was called to order at 1035 hrs.
- 1.2 Mr. Nicholas Yap provided an overview of the SCF's vision, values and goals, and outlined plans to build a sustainable paddling ecosystem in Singapore.

2. Approval of the Minutes of the AGM on 21 September 2024 ("Minutes")

- 2.1 Mr. Edvan Loh (Outward Bound Singapore) proposed the Minutes, and Mr. Shaun Ho (Invictus Canoe Kayak Sprint Club) seconded it. The Minutes were approved.

3. Outstanding matters arising from the AGM on 21 September 2024

- 3.1 There are no outstanding matters arising from the AGM on 21 September 2024.

4. Highlights in the SCF Annual Report for FYE 31 March 2025 ("FY24")

- 4.1 Ms. Noelle Seet shared a few highlights in the Annual Report:
 - (i) Events: 11 major national events were conducted. Participation in the Singapore Canoe Marathon grew from 760 participants in 2024 to 1,070 in 2025, reflecting increased interest in the sport through sustained publicity and engagement.
 - (ii) High Performance: Canoe Sprint secured medals in the SEA Canoe Sprint Championships and Asia Pacific Sprint Cup. Canoe Polo achieved significant results in the Asia Pacific Canoe Polo Championships, with the Senior Men's team winning and Senior Women's team placing second. 29 athletes were carded.
 - (iii) Community Development: Over 2,600 new one-star kayakers were certified, and 30 kayak orientation programmes were conducted. 17 new SG-Coach Level 1 and Level 2 certifications were issued. The Paracanoe programme marked its 11th year, reinforcing inclusivity as a central part of the SCF's mission.
 - (iv) Future Priorities: Preparation for Team Singapore's participation in the 2025 SEA Games and 2029 SEA Games, and continued growth of athlete and coaching pathways.

5. Approval and adoption of the Audited Statement of Accounts for FY24

- 5.1 Mr. Edvan Loh (Outward Bound Singapore) proposed the audited Statement of Accounts for FY24, and Mr. Chia Min Chong (Hwa Chong Alumni Association) seconded it. The audited Statement of Accounts for FY24 was approved and adopted.

6. Appointment of a registered auditor for Financial Year 1 April 2025 to 31 March 2026 ("FY25")

- 6.1 Mr. Ng Chek Siang sought approval to appoint SC Mohan PAC as the SCF's registered auditor for FY25.

- 6.2 Quotations from four auditors were sought via an ITQ namely, S B Tan Audit PAC, Thong & Lim, SC Mohan PAC, and RSM Stone Forest. SC Mohan PAC presented the lowest quote of \$10,464. S B Tan Audit PAC did not respond to ITQ and RSM Stone Forest declined to quote. SC Mohan PAC was the SCF's registered auditor for FY23 and FY 24 and has delivered competent work with prompt responses.
- 6.3 Mr. Shaun Ho (Invictus Canoe Kayak Sprint Club) proposed the appointment of SC Mohan PAC as the SCF's registered auditor for FY25, and Mr. Leng Song Wei (Kallang Alive Sports Management Pte Ltd) seconded it. The appointment of SC Mohan PAC as the SCF's registered auditor for FY25 was approved.

7. Record of October 2025 Payroll Transactions

- 7.1 October 2025 payroll transactions were approved by the current authorised bank signatories prior to the AGM for payment on or about 28 October 2025 ("**Transaction**"), in order that payment not be delayed due to time taken to effect the change of bank signatories with the relevant bank and Commissioner of Charities after the AGM.
- 7.2 Mr Edvan Loh (Outward Bound Singapore) acknowledged the Transaction and Mr Ng Dao Jia (Singapore Paddle Club) supported it, for record purposes.

8. Election of nine (9) Board Members of SCF, for a 2-year term from the year 2025 to 2027

- 8.1 Mr. Nicholas Yap dissolved the current Board.
- 8.2 Mr. Matthew Lee explained the nomination criteria and process as *per* Article 21 of the SCF Constitution. The Nomination Committee comprised of Mr. David Toh (Appointed Board Member) and Ms. Liew Yee Ling (Appointed Board Member). The Nomination Committee approved 10 candidates.
- 8.3 Mr. Matthew Lee explained that the election would be conducted in accordance with Articles 19.8 to 19.12 of the SCF Constitution. One representative of each Ordinary Member would be given one polling card and may vote for up to 9 candidates. Votes in excess of 9 candidates would be void. Mr. Matthew Lee introduced the 10 candidates, who were:
